

ARTICLE GUIDELINES

Journal of Liberty and International Affairs is a triannual (3 issues per year), international, open-access, and peer-reviewed journal published by the *Institute for Research and European Studies*. It welcomes submissions from political sciences, international relations, international law, and related fields. Articles are subjects to initial editorial screening and anonymous peer-review at least by two independent reviewers. The length and effectiveness of the peer-review process will largely depend upon the care used by authors in preparing their articles. The language of the articles is English. Articles without positive classification of the reviewers will not be published in the *Journal of Liberty and International Affairs*. The authors are strongly encouraged to read the article guidelines carefully before preparing an article for submission and to check the article for conformance before submitting it for publication.

Journal of Liberty and International Affairs is identified by an International Standard Serial Number (ISSN) and each article carries a Digital Object Identifier (DOI) which is a persistent identifier or handle used to identify objects uniquely, standardized by the International Organization for Standardization (ISO). The publisher and the journal have registered a deposit policy with SHERPA/RoMEO. All the articles are freely available online upon publication. They are published under the liberal Creative Commons Attribution 3.0 Unported License (CC-BY). Each article is archived in SSOAR with an assigned URN (Unique Resource Name), which is a persistent identifier (PID) that enables unequivocal and permanent access to the publication and its scientific citation. The author holds the copyright and retains publishing rights without restrictions. Articles that have been accepted will be published on the website of the journal and may be distributed to other online repositories or the author's pages on Academia.edu. To provide visibility of the published work, the journal is indexed and abstracted in multiple academic repositories and search engines. The journal editors share announcements, news, and related articles about the topic of the journal on Facebook.

Criteria for Publication

Articles should represent a substantial advance in the particular field within the scope of the journal in terms of originality; importance to researchers in the field; and interest for readers and researchers outside the field.

Anti-Plagiarism Policy

The publisher and journal have a policy of *Zero Tolerance on Plagiarism*. All articles will be checked by "PlagScan" (<http://www.plagscan.com>) before being sent to reviewers. If the case of plagiarism or duplication is detected, the article will be immediately rejected. If plagiarism or duplication is detected after publication of the article, the journal Editorial Board has the right to issue a correction or retract the published article.

Open Access Policy

Journal of Liberty and International Affairs is a fully open access journal, which means that all articles are freely available, ensuring maximum, worldwide dissemination of content, in exchange for an article publication fee. The journal provides immediate open access to its content on the principle that making research freely available to the public supports a greater global exchange of knowledge. Published material can be re-used without obtaining permission as long as a correct citation to the original publication is given.

Peer-review Policy

Journal of Liberty and International Affairs is a peer-reviewed journal, all articles being examined by researchers with credentials in the article's field of study before they are published. Articles are subjects to initial editorial screening and anonymous peer-review by two reviewers who will be selected by the editors. This journal operates a closed peer-review process, meaning that reviewers will not know author details and will themselves remain anonymous to the author. *Journal of Liberty and International Affairs* follows double-blind peer-review policy strictly.

Repository policy

The publisher and the journal have registered deposit policy with Sherpa Romeo.

Archiving

Journal of Liberty and International Affairs is archived in the National and University Library "St. Kliment Ohridski" - Skopje, Social Science Open Access Repository (SSOAR), and LOCKSS. Each full text archived in SSOAR is assigned a URN (Unique Resource Name), which is a persistent identifier (PID) that enables unequivocal and permanent access to the publication and its scientific citation. In the case of preprints and postprints of published works, you are requested to also indicate the PID of the publisher's version (as a rule, this is a Digital Object Identifier: DOI). Open Journal Systems supports the LOCKSS system to ensure a secure and permanent archive for the journal. LOCKSS is open-source software developed at Stanford University Library that enables libraries to preserve selected web journals by regularly polling registered journal websites for newly published content and archiving it.

Copyright Policy

- Authors retain copyright and grant the journal right of first publication with the work simultaneously licensed under a [Creative Commons Attribution 3.0 Unported License](#) that allows others to share the work with an acknowledgment of the work's authorship and initial publication in this journal. All materials are published under an open-access license that gives authors permanent ownership of their work.
- Authors are permitted and encouraged to post their work online (author's pre-prints on author server or institutional server only, while the author's post-prints on author's website, departmental website, employer's website, or institutional repository) before and during the submission process, as it can lead to productive exchanges, as well as earlier and greater citation of published work.
- Published sources must be acknowledged.
- Submission of an article implies that the work described has not been published before and that it is not under consideration for publication elsewhere.
- Authors are free to add (generate) DOIs to their articles published in *JLIA* using the Research Gate performances, with putting proper information of the published source.
- The journal editors are not responsible for any possible violations of existing copyright in articles published in the journal all responsibility is on the authors of those articles. The journal or publisher is not responsible for subsequent uses of the work. It is the author's responsibility to bring an infringement action if so desired by the author.

Submission Preparation Checklist

Before submitting the article, the author(s) should check the following list:

The submission has not been previously published, nor is it before another journal for consideration (or an explanation has been provided in Comments to the Editor).

The text adheres to the stylistic and bibliographic requirements outlined in the Author Guidelines.

The submission file is in Microsoft Word file format.

Consent from the authors affirming that the article is their original work should accompany the article submission via the online submission form. If the authors submit their articles via Email (contact@e-jlia.com), they should attach a signed and scanned *JLIA* Declaration of originality.

Author(s) is/are aware of the publication fee of the journal.

TITLE PAGE

Article title should be concise and informative, max. 100 characters with spaces. Titles are often used in information-retrieval systems. Avoid abbreviations and formulae where possible.

Article title: Times New Roman; 14 pt; bold; alignment centered; single line spacing; All Caps.

Example:

Author name and title: Times New Roman; bold; 14 pt; single-line spacing; alignment centered.

Affiliation, ORCID ID, and Email address: Times New Roman; *italic*, 12 pt; single-line spacing; alignment centered.

ARTICLE TEXT

Articles must be written in the English language using Microsoft Word. The scope of submitted text should not exceed more than 30.000 characters (with spaces) including references, which are typed according to the below guidelines:

- The author should follow Chicago Style (author-date system) (http://www.chicagomanualofstyle.org/tools_citationguide.html) for referencing. Example: (Dahl 1989, 45); (Geddes 1999, 134-43); (Linz 1975).
- All references should be given in full at first mention. Subsequent citations can be abbreviated. Footnotes should be kept to a minimum.
- Every reference cited in the text is also present in the reference list, and *vice versa*.
- The text should be written in the neuter gender, concisely, in correct orthography.
- Latin phrases should be set in italics (e.g. *condition sine qua non*).
- Dates should be given in the form: 26 December 1981.
- Consider aligning tables and figures at the center.
- The author is responsible for language-edit, and also, the article should be clearly and grammatically well written.

Article text: Times New Roman; 12 pt; justify; 1.5 line spacing; margins: Top: 2,5 cm; Bottom: 2,5 cm; Left: 3 cm; Right: 3 cm

Quotations: If they are brief (3 lines or fewer), quotations should be run on with the text. Longer quotations should be indented, without quotation marks. All indented quotations should be typed single-spaced.

Headings and subheadings: Times New Roman; 12 pt; bold.

Formulae and equations in the text should be given separate numbering: Eq. (1), Eq. (2), etc. Similarly for tables and figures: Table 1., Figure 1, etc.

Tables and figures:

Table 1: Heading (Source: Example, 2014)

The table heading is situated above the table.

Times New Roman; bold; size 10; align heading left; single line spacing. Tables must be created in Word, not Excel.

Figure heading is situated under the figure.

Times New Roman; bold; size 10; alignment centered; single line spacing. The authors must submit original electronic copies of the figures applied in the article in TIFF, JPG, or PNG format.

ACKNOWLEDGEMENT

Financial support, advice, or other kinds of assistance can be included in this section.

REFERENCES

The reference list appears at the end of your article and provides more detailed information about the sources you cited. Each entry in the reference list also begins with the author's last name and the publication date, so that your reader can easily find any source they encounter in the text. It is alphabetized by the author's last name.

BOOKS

One author

Pollan, Michael. 2006. *The Omnivore's Dilemma: A Natural History of Four Meals*. New York: Penguin.

Two or more authors

Ward, Geoffrey C., and Ken Burns. 2007. *The War: An Intimate History, 1941–1945*. New York: Knopf.

For four or more authors, list all of the authors in the reference list; in the text, list only the first author, followed by *et al.* ("and others")

Editor, translator, or compiler instead of author

Lattimore, Richmond, trans. 1951. *The Iliad of Homer*. Chicago: University of Chicago Press.

Editor, translator, or compiler in addition to the author

García Márquez, Gabriel. 1988. *Love in the Time of Cholera*. Translated by Edith Grossman. London: Cape.

Chapter or other parts of a book

Kelly, John D. 2010. "Seeing Red: Mao Fetishism, Pax Americana, and the Moral Economy of War." In *Anthropology and Global Counterinsurgency*, edited by John D. Kelly, Beatrice Jauregui, Sean T. Mitchell, and Jeremy Walton, 67–83. Chicago: University of Chicago Press.

Chapter of an edited volume originally published elsewhere (as in primary sources)

Cicero, Quintus Tullius. 1986. "Handbook on Canvassing for the Consulship." In *Rome: Late Republic and Principate*, edited by Walter Emil Kaegi Jr. and Peter White. Vol. 2 of *University of Chicago Readings in Western Civilization*, edited by John Boyer and Julius Kirshner, 33–46. Chicago: University of Chicago Press. Originally published in Evelyn S. Shuckburgh, trans., *The Letters of Cicero*, vol. 1 (London: George Bell & Sons, 1908).

Preface, foreword, introduction, or similar part of a book

Rieger, James. 1982. Introduction to *Frankenstein; or, The Modern Prometheus*, by Mary Wollstonecraft Shelley, xi–xxxvii. Chicago: University of Chicago Press.

E-BOOKS

If a book is available in more than one format, cite the version you consulted. For books consulted online, list a URL; include an access date only if one is required by your publisher or discipline. If no fixed page numbers are available, you can include a section title or a chapter, or other numbers.

Kurland, Philip B., and Ralph Lerner, eds. 1987. *The Founders' Constitution*. Chicago: University of Chicago Press. <http://press-pubs.uchicago.edu/founders/>.

JOURNAL ARTICLE

Article in a print journal

Weinstein, Joshua I. 2009. "The Market in Plato's *Republic*." *Classical Philology* 104:439–58.

Article in an online journal

Include a DOI (Digital Object Identifier) if the journal lists one. A DOI is a permanent ID that, when appended to <http://dx.doi.org/> in the address bar of an Internet browser, will lead to the source. If no DOI is available, list a URL. Include an access date only if one is required by your publisher or discipline.

Article in a newspaper or popular magazine

Newspaper and magazine articles may be cited in running text ("As Sheryl Stolberg and Robert Pear noted in a *New York Times* article on February 27, 2010..."), and they are commonly omitted from a reference list.

The following examples show the more formal versions of the citations. If you consulted the article online, include a URL; include an access date only if your publisher or discipline requires one. If no author is identified, begin the citation with the article title.

Book review

Thesis or dissertation

Website

A citation to website content can often be limited to a mention in the text ("As of July 19, 2008, the McDonald's Corporation listed on its website..."). If a more formal citation is desired, it may be styled as in the examples below. Because such content is subject to change, include an access date or, if available, a date that the site was last modified. In the absence of a date of publication, use the access date or last-modified date as the basis of the citation.

Google. 2009. "Google Privacy Policy." Last modified March 11. <http://www.google.com/intl/en/privacypolicy.html>.

McDonald's Corporation. 2008. "McDonald's Happy Meal Toy Safety Facts." Accessed July 19. <http://www.mcdonalds.com/corp/about/factsheets.html>.

Blog entry or comment

Blog entries or comments may be cited in running text ("In a comment posted to *The Becker-Posner Blog* on February 23, 2010..."), and they are commonly omitted from a reference list. If a reference list entry is needed, cite the blog post there but mention comments in the text only. (If an access date is required, add it before the URL; see examples elsewhere in this guide.)
